





#### TOBACCO CONTROL

India is home to about 269 million tobacco users (roughly 27 crore): 200 million of them use smokeless or chewed forms of tobacco: nearly 100 million smoke bidis or cigarettes; and 3.2 crore smoke and as well as chew tobacco. Over 1.3 million (or 13 lakh) people die from tobacco use every year, primarily from smoking. Exposure to second hand Smoke (SHS) which also causes numerous health problems causes additional deaths. Rajasthan is the largest state of India by the area and is home of 11.9 million tobacco users with majority of tobacco users smoke bidi or chew tobacco; nearly 6.8 million of them chew tobacco; nearly 6.3 million of them smoke bidi or cigarette; and 1.2 million of them smoke as well as chew tobacco.

India became a party to the WHO Framework Convention on Tobacco Control (FCTC) in 2005. The national tobacco control law is the Cigarettes and Other Tobacco Products (Prohibition of Advertisement and Regulation of Trade and Commerce, Production, Supply and Distribution) Act, 2003 (COTPA). To ensure the effective implementation of the act in Rajasthan SRKPS has two grants.

#### **INDIA**

- 19.0% of men, 2.0% of women and 21.4% of all adults currently smoke tobacco
- 29.6% of men, 12.8% of women and 21.4% of all adults currently use smokeless tobacco.
- 42.4% of men, 14.2% of women and 28.6% of all adult currently either smoke tobacco and /or use smokeless tobacco.
- Khaini and bidi are the most commonly used tobacco products.

11% of adults consume khaini and 8% smoke bidi.

#### **RAJASTHAN**

- 22.2% of men, 3.7% of women and 13.2% of all adults currently smoke tobacco.
- 22.0% of men, 5.8% of women and 14.1% of all adults currently use smokeless tobacco.
- 39.6% of men, 9.0% of women and 24.7% of all adults either smoke tobacco and/ or use smokeless tobacco.
- Bidi and Gutka are the two most commonly used tobacco products, 11.4% of adults smoke Bidi and 9.0% of adults use Gutka.



# PROJECT- ADVANCING COMPREHENSIVE TOBACCO CONTROL IN RAJASTHAN THROUGH INSTITUTIONAL DEVELOPMENT, CAPACITY BUILDING, AND EFFECTIVE IMPLEMENTATION OF MPOWER MEASURES CONTROL

The project was initiated with the aim to strengthen tobacco control efforts in Rajasthan through high-level sensitization of policymakers, capacity building among enforcement officials at state and district level, and support formulation of new policies upon request of the Government. SRKPS engages with policymakers, enforcement officials, and officials of urban and local bodies and Panchayati Raj Institutions, to strengthen the enforcement mechanism of tobacco control in state.

SRKPS works closely with state and district-level CSOs, NGOs, networks, media houses and communities to bring incorporate tobacco control activities and messages in their missions, and sustain behavioral change to 'denormalise' tobacco within the society at large.

#### **ACTIVITIES**

- Strengthened institutionalization of NTCP and COTPA implementation including monitoring and reporting within the state to sustain tobacco control efforts across the state of Rajasthan with a focus on intervention districts.
- Supported capacity building and sensitization of key stakeholders at the state and district level.
- Supported state and district cells to adopt new policies to advance tobacco control.
- Conducted strategic policy-focused research for monitoring and evaluation of tobacco control implementation.

The project is to make ensure effective implementation of Tobacco Free Educational Institution Guideline (ToFEI)- 2019 of Ministry of Medical, Health and Family Welfare, Government of India at all educational institutions with the aim to make children healthy and tobacco free. The program aligns with National Tobacco Control Program to achieve the objectives of WHO FCTC and SDG 3 with the moto "Children lead a tobacco - free healthy life empowered with knowledge about the ill - effects of tobacco, good hygiene and nutrition practices, thereby ensuring that they can thrive with a sustainable societal health outcome".

The program builds capacity of educational institutions provide tobacco to free environment at school level, provides support building for mechanism effective implementation of ToFEI-2019 quidelines, sensitization activities at school level on ill effects of tobacco use, motivate children to eliminate tobacco use at household level, etc. The program sensitizes teachers, children and parents to create healthier future.

QUALITY

One in nine persons worldwide are undernourished, and one in three are overweight or obese. Nearly a quarter of all children under 5 have stunted growth, indicating that the issue begins early (chronically undernourished). Regardless of GDP, malnutrition affects nations, and progress is sluggish. SRKPS and NSF (Nourishing School Foundation) have collaborated to implement a system changing pilot for the "Nourishing School" program aimed at reducing malnutrition in rural India. In order to work together to minimise undernutrition, SRKPS is surveying schools and students in the target

segment and acting as a conduit for them to access

that up to 120 students are surveyed, i.e., 20 in each grade, with a balanced distribution of boys and girls

Holistic Development of Children, women and adolescents girls by building the knowledge and capacity to demand and access services

Under the collaborative direction of SRKPS, NUVOCO Chittor Cement Plant, and ICDS(Integrated Child Development Department), this initiative is being carried out. The project's goal is to promote the holistic development of children, women, and adolescent girls by ensuring the provision of high-quality services in Anganwadi facilities. The following activities would be carried out in 72 Anganwadi centres in 63 villages in the Nimbahera block of the Chittorgarh district. Project Anagan focused in

- Making ANC testing available to pregnant women for timely diagnosis of High risk preganancies.
- Making sanitary pads available to adolescent girls at Anganwadi
- Establishing mechanism for Referral and linkage services for malnourished children at Anganwadi centres.
- Setting up Nutrigardens at Anganwadi to provide fortified meals to malnourished children and pregnant women.

#### A POSITIVE RAY OF HOPE



Kiran, 23 years resident of Arniya Joshi had her first ANC in August 2020 and when tested with digital ANC kit her Hb was found as low as 6.9. She was put under high-risk pregnancy by the ANM and was instructed to take a nutritious diet along with IFA tablets. Similar process of testing Hb with ANC kit was done during her next ANCs to track the progress; Kiran was glad now she do not have to travel to the town to get her Hb tested, and she feels independent as no one need to take her or accompany her for the regular health check-ups.

Regular monitoring of Hb helped her to modify the diet contents and motivated her to take the medicines regularly resulting in 11 Hb in her 4th ANC and she gave birth of a healthy baby boy on 3 March 2021.

Like this case project team is ensuring regular follow-ups with HRPs and digital ANC kit is proved to be an asset in saving lives of mother and child both.

#### TI- INJECTION DRUG USERS (IDUS)

IDUs make up the third HRG, and focused therapies are crucially important for them. HIV can spread quickly within networks of IDUs who share injecting equipment because it is extremely contagious through the sharing of needles and other injection supplies. Once the IDU group has a high HIV prevalence, it can spread swiftly into their sexual networks. It is possible to swiftly connect HIV transmission in IDU networks to transmission in the larger high-risk sexual networks since some IDUs also work as sex workers

The TI initiative in Rajasthan's Kota district, with a goal of 400 IDUs (Injecting Drug Users), has been underway since March 2011 thanks to financial support from RSACS (Rajasthan State AIDS Control Society), Jaipur. We concentrate on each of the six elements of TI as part of focused interventions:

- Provision of commodities
- Clinical services
- Enabling environment
- Behavioral Communication change
- Community Mobilization
- Referral and Linkages

#### **ACTIVITIES**

- For the prevention of HIV/AIDS, needle syringes and condoms are provided.
- Testing blood of HRGs in ICTC and F- ICTC
- Referring to IDU/HRG in ART, STD, DOTS, OST
- Transforming injectable drug users' (IDUs') highrisk behaviour into low-risk behavior
- Educating injectable drug users (IDUs) on safe injection techniques

- For the years 2021-2022, we held three health camps in the hotspot area, screening 134 HRGs and administering HIV and STI tests, with 12 new cases reported.
- To evaluate family issues in the HRG group, three advocacy meetings were organised in 2021–2022, however we are happy to report that no issues have surfaced this year.

## TARGET INTERVENTION - FEMALE SEX WORKER (FSW)

Targeted Intervention Programme of SRKPS supported by Rajasthan State AIDS Control Society is one of the most effective means of controlling the spread of HIV in the community. A project called "Targeted Intervention" has been working with those who are most susceptible to HIV/AIDS, namely female sex workers (FSWs).

According to estimates, unprotected sexual contact between an infected person and an uninfected person accounts for more than 90% of HIV transmission in India. In modern society, the majority of HIV transmission takes place among networks or groups of people who are at high risk due to having several sexual partners.

SRKPS focuses on one core composite high risk group (HRG) of people who are most at danger under core composite Targeted Intervention, namely female sex workers (FSWs).

SRKPS is implementing the project in Bhawani Mandi, a municipality town in Jhalawar district of Rajasthan. Bhawani Mandi is known for its massive orange market, thus HRGs affiliated with it come here in search of business. The orange business here lasts for 8 months. People come from UP, Bihar, MP, Maharashtra, Nepal, and other states to work in this area. At least 8000 HRG are employed in these factories.

#### **ACTIVITIES**

- To set-up project management systems and structure to initiate interventions with Female Sex Workers (FSWs) in Bhawani Mandi block of Jhalawar District, Rajashan.
- To increase awareness regarding STI, HIV and AIDS by initiating BCC activities and mobilizing the community.
- To promote the effective usage of condoms and ensure availability and accessibility of the same among the FSW population.

CHILDLINE 1098, Jhunjhunu was launched in September 2016 and has since reached every town and village in the district.

#### **ACHIEVEMENTS**



A total of **589** cases were reported on Childline Jhunjhunu for the **2021–2022** fiscal year, including many different types of cases involving education, health, child marriage, child labour, violence against children, missing children, and so forth. In each of these cases, the child line team's intervention helped the child.





